

## Tech CU Mortgage Loan Officer NMLS ID Numbers

The Secure and Fair Enforcement for Mortgage Licensing Act (**SAFE Act**) is designed to enhance consumer protection and reduce fraud by requiring a nationwide registration system for Mortgage Loan Originators (MLO). Each MLO obtains a unique identifier from the **National Mortgage Licensing System and Registry (NMLS)**. This information will allow a consumer applying for a mortgage loan to verify the MLO is properly registered and obtain basic information about the MLO regarding their history in this area. **Tech Credit Union institution ID: 401705**
